In our facilities or at the customer site

Execution of public accounting services (CNS-AP) and related technical accountability can be made at our facilities or at the customer site with our computer resources or the public entity computer resources and through our professional staff and/or coordination of professionals in the public entity.

To provide these services are generally performed the following tasks:

Monthly reporting of the funds available in the DGO (until the 10th business day of the next month to which it relates); Monthly reporting of commitments, accounts payable and late payment in SIGO (until the 10th business day of the next month to which it relates); Quarterly reporting of information relating to Treasury unit in DGO (15th of the month following the end of the quarter); Accountability as Accountant Certificate; Displacement of technical staff for coordinating the implementation of the general and / or analytical accounts; Monthly reporting of charges map with staff and no effective in SIGO; Annual Report of the provision of annual accounts by 30 April; Annual Report of the balance of the previous run until 30 April.
